CHANGES AND ADDITIONS TO THE AGENDA – None

ITEMS FOR DISCUSSION AND ACTION BY THE BOARD

1. APPROVAL OF MINUTES For May 11, 2018

Minutes were reviewed and approved as presented (6-0).

2. RECREATION PROGRAMMING UPDATE

The following items were discussed as related to the 2018 recreation season:

- Mr. Brauer provided a summary of the 2018 National Trails Day event, sponsored and coordinated by the Town of Castle Rock. Approximately 100 hikers, 65 kayaks/canoes and 20 SUP participated in the day. There were no safety violations or incidents reported. Inspections were provided for the day's event.
- Both the SUP and Avid teams kicked off their summer programs at the end of May.
 Discussion ensued regarding emergency protocol. Mr. Redd clearly stated that vehicles are explicitly prohibited on the dam.
- Application forms, including associated requirements for additional programs have been sent out to both the open swim club and running organization who have expressed interest in holding events this summer. Additionally, the Girl Scouts day camp has inquired about possible opportunities for 2019.
- As many parties are getting numerous calls and contacts requesting the ability to bring their own watercraft out to the reservoir, Mr. Burkhardt will check with the County as to what would trigger Hess Road improvements (hence, being considered "open to the public").
- The Board agreed that it would be prudent to meet on June 22nd to further discuss emergency response plans and prioritize 2018-19 capital projects.

3. DISCUSSION & CONSIDERATION of PROJECT PLANNING OR 2018

Mr. Redd summarized a proposal provided by Wenk to design and contract the addition of shade structures, an overlook deck and a restroom enclosure.

A motion was made and seconded to approve the proposal with Wenk (Mr. Dykstra to draft an amendment to Wenk's current agreement with the Authority), in amount of \$52,240. The motion was approved unanimously by the Board.

FOLLOW-UP DISCUSSIONS

- For the June 22nd meeting, a proposed amendment to the current COSS contract with the Town of Parker will be considered, allowing personal watercraft with proper inspection processes in place (COSS to become certified).
- The Board requested Mr. Dykstra draft a Resolution for the next RHR Authority meeting authorizing signature authority for Manager, Susan Saint Vincent in an amount to be determined by the Board.
- The electric work project to the entrance shed has been complete; Ms. Saint Vincent will forward an invoice for the contractor for payment.

MEETING ADJOURNMENT

The meeting was formally adjourned at 10:25am.
